**Terms and conditions:**

1. The consignment shall be accompanied by an official health certificate issued by the authorized officer of the competent authority of the exporting country containing the following declarations:

- a. The product was processed in compliance with HACCP norms in approved processing establishment under control of the competent authority having approved residue monitoring program.
- b. The product was tested on random sampling basis in accredited laboratory prior to export and no pathogenic microorganisms, antibiotics, veterinary drug residues, pesticides, heavy metals, unauthorized dyes, steroids or any other health hazardous substance detected above the permitted limit as per regulations of Bangladesh.
- c. The product is fit for human consumption.


2. For frozen and cured fish and fishery product, the consignment should accompanied by test report of harmful pathogenic microorganisms, antibiotics, veterinary drug residues, pesticides, heavy metals, unauthorized dyes, steroids from accredited laboratory.

3. On arrival, the consignment and the documents will be examined by the official Inspector/Authorised Officer of the Department of Fisheries, Bangladesh and samples will be drawn for laboratory analysis for microbiological/ chemical hazards as per Fish and Fishery Products (Inspection and Quality Control) Act, 2020. The expense for laboratory testing will be borne by the importer.

4. In case of adverse findings in laboratory analysis, appropriate action shall be taken by the Department of Fisheries as per Fish and Fishery Products (Inspection and Quality Control) Act, 2020/ Customs regulations of Bangladesh at the cost of importer.

5. The importer should provide an undertaking that the products will be used for intended purpose only and at no point of time, the imported product shall find way to animal food chain.

6. This permit is granted under Section 23 of Fish and Fishery Products (Inspection and Quality Control) Act, 2020 and is without prejudice to the application of any other prohibition or regulation affecting the import of



goods which may be in force at the time of arrival.

7. This permit is valid for six (06) months from the date of issue. However, Government may, in public interest, decide to revoke an import permit before its expiry.

8. This permit is valid for multiple consignments and is not transferable.
