### Position Overview:

Analyst – Impact & Ecosystem role is equally responsible for Impact and Startup Ecosystem Development functions of Startup Bangladesh Limited (SBL). On the Impact side, the role assists operational execution of grant sourcing, project implementation, collaboration and reporting. The other part will be portfolio impact data collection, measurement, and reporting, ensuring alignment with national priorities, donor requirements, and global impact frameworks. On the Ecosystem Development side, the role will support different initiatives taken by SBL regarding startup pipeline generation, ecosystem coordination, partnership development, policy advocacy, event execution, etc. contributing to SBL's mandate of building a strong, inclusive, and globally connected startup ecosystem.

### Specific Responsibilities:

- **Grant & Donor Management:** Support the sourcing and management of grants and blended finance/technical assistance funds; prepare grant proposals, concept notes, budgets, and MoUs; coordinate donor compliance requirements; track implementation milestones; and maintain complete documentation for audits and reporting.
- **Impact Measurement & Management:** Integrate impact metrics across investment, monitoring, and exit processes; collect, validate, and consolidate portfolio impact data; guide portfolio startups on impact KPIs, data quality, and reporting standards; and maintain impact dashboards, trackers, and databases.
- **Reporting & Evaluation:** Support quarterly, annual, investor, and donor impact reporting; prepare progress updates, impact summaries, and management briefs; and assist with impact audits, third-party evaluations, and verification processes.
- **Portfolio Support & Growth:** Support investment teams with impact inputs during deal sourcing and structuring; connect portfolio startups with mentors, investors, and ecosystem partners; identify aligned follow-on investors and partnerships; and support impact-aligned exit planning and documentation.
- **Ecosystem Development & Research:** Support the design, planning, and execution of ecosystem programs and events; coordinate participant data and post-event reporting; track ecosystem outputs and outcomes; conduct sectoral and thematic impact research; and develop policy notes, impact briefs, case studies, and success stories.

- Partnerships, Communication & Advocacy: Maintain and strengthen relationships with government agencies, development partners, investors, corporates, and ecosystem enablers; support impact-focused communications and visibility of portfolio startups; and represent SBL in local and global ecosystem forums.
