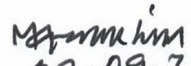
Subject: **Government Order (G.O) for Deputation.**

The undersigned is directed to convey the Government's approval of deputation to Mr. Md. AMIT HASAN (PP No: A09925000), Assistant Network Engineer, District Office, Kushtia, Department of Information and Communication Technology under ICT Division Selected for the Global Korea Scholarship (GKS) Program under the National Institute for International Education (NIIED), affiliated with the Ministry of Education of South Korea, to pursue Master's Program at the Department of Digital Anti-Aging Healthcare, Major in Artificial Intelligence, Inje University, South Korea from 01.09.2026 to 31.08.2029 (or from the nearest possible date) excluding transit period under the following terms and conditions:

- a. He will start his journey for South Korea on a convenient date near to 03.09.2026;
- b. Total period of this program and the time spent for travel and transit will be treated as on duty;
- c. He will draw all parts of his pays and allowances in local currency and not in foreign currency;
- d. The participant will send a progressive report of his studies from his professor or from the university authority every 06 (six) months interval;
- e. The participant shall return to Bangladesh immediately upon completion of the deputation and upon his return, he must serve continuously in Government service for a mandatory period of one (1) year;
- f. All expenses of the said course will be borne by National Institute for International Education (NIIED), South Korea;
- g. He will not be allowed to stay abroad more than the approved period;
- h. He must have to submit awarded certificate and a copy of the thesis paper to ICT Division within 05 (five) days after his return from/completion of the program.
