1. The People's Republic of Bangladesh has applied for financing from the Asian Development Bank (ADB) toward the cost of Khulna Water Supply Project (Phase-2). Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.

2. The Khulna Water Supply and Sewerage Authority ("the Employer") invites sealed bids from eligible Bidders for the construction and completion of "Construction of Clear Water Transmission Main including Mayur River and Canal Crossing" ("The Works").

3. Open competitive bidding will be conducted in accordance with ADB's **Single-Stage: Two-Envelope** bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.

4. Only eligible Bidders with the following key qualifications defined in the Bidding Document may participate in this bidding:

- (i) Minimum average annual construction turnover USD **20** million during last **five(5) years**
- (ii) Participation in at least one similar contact to the proposed works within last **ten (10)** years successfully or substantially completed where the value of the bidder's participation exceeds USD **25** million.
- (iii) Demonstrates total financial resources required equal to or above the USD **4.3** million for subject contact.
- (iv) The complete qualification criteria are described in the bid document.
