- i) He is ineligible to apply for permanent residency and citizenship while studying abroad;
- Ile will have to return the salary and allowances drawn during the period of study leave in case of his failure to serve the Government at least one year from his return;
- k) All terms and conditions under the Public Administration Training Policy, 2023 and other related Rules and Regulations for training /studing abroad will be applicable.
