
Notification

In consultation with the Supreme Court of Bangladesh, the Government of Bangladesh has granted study leave from 01/09/2025 to 15/09/2027 in favour of the following Judicial Officer for studying 'Master's Degree in Legal Studies (Curriculum-Law and Digital Transition) at the Bologna University, Italy under the following terms and conditions:

Terms and condition :

- a) This study leave will not be deducted from his account of leave;
 - b) He will not receive any study allowances;
 - c) During his study leave he will be entitled to his salary on half-average pay basis;
 - d) The Government of Bangladesh shall not bear any expenditure for this study;
 - e) He will return to Bangladesh after the period of study leave;
 - f) Any stay abroad beyond the permitted period without prior permission of the Government of Bangladesh will be treated as illegal;
 - g) He will not borrow any loan abroad and will have to make payment of all the dues before him return;
 - h) He will have to submit awarded certificate and a report to the Law and Justice Division within five days of his return to Bangladesh after completing the course;
 - i) He is ineligible to apply for permanent residency and citizenship while studying abroad;
 - j) He will have to return the salary and allowances drawn during the period of study leave in case of his failure to serve the Government at least one year from his return;
 - k) All terms and conditions under the Public Administration Training Policy, 2023 and other related Rules and Regulations for training /studying abroad will be applicable.
2. This order is issued with the approval of the competent authority.


