
**Notification**

In consultation with the Supreme Court of Bangladesh, the Government of Bangladesh has granted deputation from 01/01/2026 to 20/01/2027 in favour of the following Judicial Officer for studying 'Master of Laws' at the University of New South Wales, Australia funded by 'Australia Awards Scholarship' by the Government of Australia under the following terms and conditions:

**Terms and condition :**

- k) The approved period of her deputation will be treated as on duty;
  - l) She will draw all her pay and allowances in local currency;
  - m) The Government of Bangladesh shall not bear any expenditure for this study;
  - n) She will return to Bangladesh after the period of deputation;
  - o) Any stay abroad beyond the permitted period without prior permission of the Government of Bangladesh will be treated as illegal;
  - p) She will not borrow any loan abroad and will have to make payment of all the dues before her return;
  - q) She will have to submit awarded certificate and a report to the Law and Justice Division within five days of her return to Bangladesh after completing the course;
  - r) She is ineligible to apply for permanent residency and citizenship while studying abroad;
  - s) She will have to return the salary and allowances drawn during the period of deputation in case of her failure to serve the Government at least one year from her return;
  - t) All terms and conditions under the Public Administration Training Policy, 2023 and other related Rules and Regulations for training /studying abroad will be applicable.
2. This order is issued with the approval of the competent authority.


