

**Notification**

In consultation with the Supreme Court of Bangladesh, the Government of Bangladesh has granted study leave to Mr. Nayan Chandra Modak, Attached Officer (Joint District and Sessions Judge), Law and Justice Division from 20/08/2025 to 19/08/2027 or from the actual date of commencement whichever is later for studying Masters in Peace, Mediation and Conflict Research at Abo Akademi University, Finland under the following terms and conditions :

- a) This study leave will not be deducted from his account of leave;
  - b) He will not receive any study allowances;
  - c) During his study leave, he will be entitled to his salary on half-average pay basis;
  - d) The Government of Bangladesh shall not bear any expenditure for this study;
  - e) He will return to Bangladesh immediately after period of study leave;
  - f) Any stay abroad beyond the permitted period without prior permission of the Government of Bangladesh will be treated illegal;
  - g) He will not borrow any loan abroad and will have to make payment of all the dues before his return;
  - h) As soon as the period of study leave ends, he will join the service and will have to submit a copy of the course completion certificate on his return;
  - i) He will have to return the salary and allowances drawn during the period of study leave to the Government in case of his failure to serve the Government at least two years from his return.
2. This order is issued with the approval of the competent authority.


