
**Notification**

In consultation with the Supreme Court of Bangladesh, the Government of Bangladesh has granted deputation from 22/09/2025 to 21/09/2026 or until this course is completed (whichever occurs earlier) in favour of the following Judicial Officer for studying 'LLM in Criminal Law and Criminal Justice' at the University of Sussex, United Kingdom funded by 'Chevening Scholarship' of the British Government under the following terms and conditions:

**Terms and condition :**

- The approved period of his deputation will be treated as on duty;
  - He will draw all his pay and allowances in local currency;
  - The Government of Bangladesh shall not bear any expenditure for this study;
  - He will return to Bangladesh after the period of deputation;
  - Any stay abroad beyond the permitted period without prior permission of the Government of Bangladesh will be treated as illegal;
  - He will not borrow any loan abroad and will have to make payment of all the dues before his return;
  - He will have to submit awarded certificate and a report to the Law and Justice Division within five days of his return to Bangladesh after completing the course;
  - He is ineligible to apply for permanent residency and citizenship while studying abroad;
  - He will have to return the salary and allowances drawn during the period of deputation in case of his failure to serve the Government at least one year from his return;
  - All terms and conditions under the Public Administration Training Policy, 2023 and other related Rules and Regulations for training /studying abroad will be applicable.
2. This order is issued with the approval of the competent authority.


