- g) He will have to submit awarded certificate and a report to the Law and Justice Division within five days of his return to Bangladesh after completing the course;
- h) He is ineligible to apply for permanent residency and citizenship while studying abroad;
- i) He will have to return the salary and allowances drawn during the period of deputation in case of his failure to serve the Government at least one year from his return;
- j) All terms and conditions under the Public Administration Training Policy, 2023 and other related Rules and Regulations for training /studying abroad will be applicable.
