
**Notification**

**Terms and condition:**

- a) Her period of deputation will be treated as on duty;
  - b) She will draw her pay and allowances in local currency only during the period of deputation;
  - c) The Government of Bangladesh shall not bear any expenditure for this study;
  - d) She will return to Bangladesh after the period of extra-ordinary leave;
  - e) Any stay abroad beyond the permitted period without prior permission of the Government of Bangladesh will be treated illegal;
  - f) She will not borrow any loan abroad and will have to make payment of all the dues before her return;
  - g) As soon as the period of extra-ordinary leave ends, she will join the service and will have to submit a copy of the course completion certificate;
  - h) She will have to return the salary and allowances drawn during the period of deputation in case of her failure to serve the Government at least two years from her return.
