

**Terms and condition:**

- a) His period of deputation will be treated as on duty;
- b) He will draw his pay and allowances in local currency;
- c) The Government of Bangladesh shall not bear any expenditure for this study;
- d) He will return to Bangladesh after the period of study leave;
- e) Any stay abroad beyond the permitted period without prior permission of the Government of Bangladesh will be treated illegal;
- f) He will not borrow any loan abroad and will have to make payment of all the dues before his return;
- g) As soon as the period of study leave ends, he will join the service and will have to submit a copy of the course completion certificate;
- h) He will have to return the salary and allowances drawn during the period of deputation in case of his failure to serve the Government at least two years from his return.
