- h) He is ineligible to apply for permanent residency and citizenship while studying abroad;
- i) He will have to return the salary and allowances drawn during the period of deputation in case of his failure to serve the Government at least one year from his return;
- All terms and conditions under the Public Administration Training Policy, 2023 and other related Rules and Regulations for training/studying abroad will be applicable.
