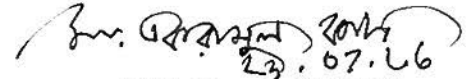

Notification

- e. As per provision of Rule 34 of Appendix VIII of BSR (Part-1), this notification will be valid for 35 days from 24 July 2026.

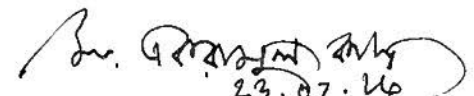
