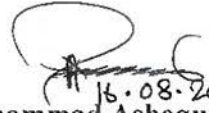

Notification

In consultation with the Supreme Court of Bangladesh, the Government has granted Ex-Bangladesh leave (Earned Leave) for 40 (forty) days in favour of Mr. Md. - d. As per provision of Rule 34 of Appendix VIII of BSR (Part-I), this notification will be valid for 35 days from 17 August 2026.

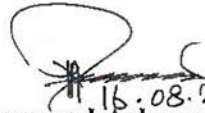
