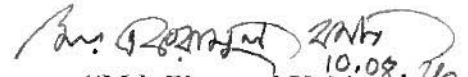

Notification

In consultation with the Supreme Court of Bangladesh, the Government has granted Ex-Bangladesh leave (Earned Leave) to Mr. Md Rashed Hossain, Additional Chief Metropolitan Magistrate, Rangpur (Passport No. E00258792) for the purpose of visit to India. Terms and Conditions:

- a. He will leave from Bangladesh on 16.08.2026 or nearer possible date and will return to Bangladesh on 30.08.2026 or nearer possible date.
- b. He will draw his pay and allowances in local currency. No part of it should be drawn in foreign currency. All related expenses of the visit will be borne by him;
- c. His mother Mst Hosne Ara Begum will accompany him during this travel;
- d. As per provision of Rule 34 of Appendix VIII of BSR (Part-I), this notification will be valid for 35 days from 11 August 2026;
- e. The Notification No. 10.00.0000.127.25.006.25.468, dated 14 June 2026 is hereby cancelled.

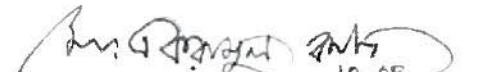
