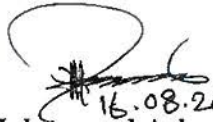

Notification

In consultation with the Supreme Court of Bangladesh, the Government has granted Ex-Bangladesh leave (Earned Leave) for 30 (thirty) days in favour of Mr. R.Q.M. Zulker Nien, Chief Metropolitan Magistrate, Rangpur (Passport No. E00111289) for the purpose of visit to Australia. This leave has been granted to enable him to accompany his family and to take care of his critically ill sister-in-law under the following terms and conditions:

Terms and Conditions:

- a. He will leave from Bangladesh on 30.08.2026 or nearer possible date and will return to Bangladesh on 28.09.2026 or nearer possible date.
- b. He will draw his pay and allowances in local currency. No part of it should be drawn in foreign currency. All related expenses of the visit will be borne by him;
- c. His wife Farhana Khan and daughter Juhi Farial will accompany him during this visit;
- d. As per provision of Rule 34 of Appendix VIII of BSR (Part-I), this notification will be valid for 35 days from 17 August 2026.

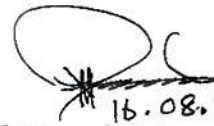
