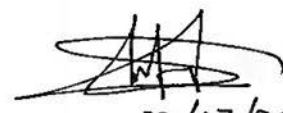
Notification

Terms & Conditions:

- (d) He will have to submit a report on his participation in the Conference to the Law and Justice Division within five days after his return from the Conference.

(2) The order is issued with the approval of the competent authority.

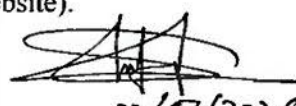
