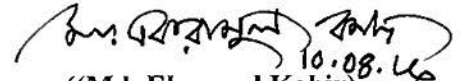

Notification

In consultation with the Supreme Court of Bangladesh, the Government has granted Ex-Bangladesh leave (earned leave) to Mr. Md. Terms and Conditions:

- b. He will draw his pay and allowances in local currency. No part of it should be drawn in foreign currency. All related expenses of the visit will be borne by him;
- c. His wife Umme Hany Mafruha and brother-in-law Moquaddash Ahmed will accompany him during this travel;
- d. As per provision of Rule 34 of Appendix VIII of BSR (Part-1), this notification will be valid for 35 days from 11 August 2026;
- e. The Notification No. 10.00.0000.127.25.010.25.480, dated 18 June 2026 is hereby cancelled.

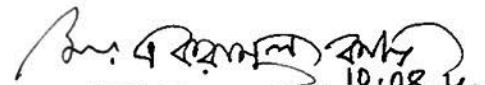
