In consultation with the Supreme Court of Bangladesh, the Government of Bangladesh has granted deputation with effect from 23/09/2026 until the conclusion of the two years course in favour of the following Judicial Officer for completing Master's Program in Law (LLM) in Kyushu University, Japan funded by the Japan International Cooperation Agency (JICA) under the terms and conditions below:

Terms and Conditions:

- The approved period of her deputation will be treated as on duty;
- She will draw all his pay and allowances in local currency;
- The Government of Bangladesh shall not bear any expenditure for her study;
- She will return to Bangladesh after the period of deputation;
- Any stay abroad beyond the permitted period without prior permission of the Government of Bangladesh will be treated as illegal;
- She will not borrow any loan abroad and will have to make payment of all the dues before her return;
- As soon as the period of deputation ends, she will join the service and will have to submit a copy of the course completion certificate within seven days of her return to Bangladesh after completing the course;
- She is ineligible to apply for permanent residency and citizenship while studying abroad;
- She will have to return the salary and allowances drawn during the period of deputation in case of her failure to serve the Government at least one year from her return;
- All terms and conditions under the Public Administration and Training Policy, 2023 and other related Rules and Regulations for training/studying abroad will be applicable.

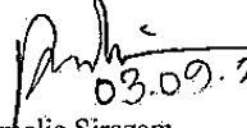
