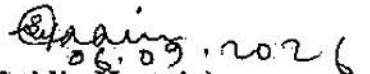

- d. All related expenses of the travel will be borne by her Full funded bursary (Travel and Accommodation).

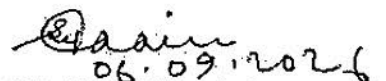
