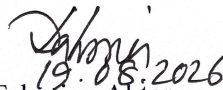

- c. The approved leave must be started within 35 (thirty-five) days from the date of the approval; otherwise, the approval will cease to remain in force as per the provision of Rule 34 of Appendix VIII of BSR (Part-1).
- d. He will not be allowed to stay abroad more than the approved period; and
- e. This leave is granted under the conditions of Leave Rules, 2017 for the Chairman, Members, and Reserved Seat Women Members of the District Council.

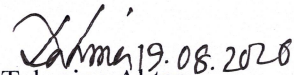
