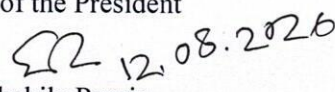

- (e) After returning to the country, he will inform the concerned authority.

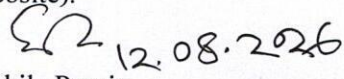
