
## Contract Agreement

THIS AGREEMENT, made the 23 April 2019 between Upazila Engineer, Local Govt. Engineering Department, Companiganj, Noakhali (hereinafter called "the Procuring Entity") of the one part and BEST WEST ENGINEERING PVT. LTD , Pro: MD. NURUL KARIM, Hazari Hat, Char Hazari, Companiganj, Noakhali, (hereinafter called "the Contractor") of the other part.

WHEREAS, the Procuring Entity invited Tenders for certain Works, viz, Construction of Class Room of HAJI MAHBUBUL HOQUE Govt. Primary School under Companiganj, Noakhali, Need Based Infrastructure Development of Newly Nationalized Govt. Primary School (1st phase) (NBIDNNGPS), Package No : e-Tender/NBIDGNNPS/NKL/COM/2018-19/W1. 03477 (e-Tender notice No: 1/2018-19 , Tende ID No: 288685 ) and has accepted a Tender by the Contractor for the execution of those works in the sum of Tk. 1,13,66,233.97 ( One Crore Thirteen Lac Sixty Six Thousand Two Hundred Thirty Three Point Nine Seven Only ). (hereinafter called "the Contract Price.)

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

  - h) The Drawings;
  - i) The priced Bill of Quantities and the Schedules
  - j) Any other document listed in the PCC as forming part of the Contract.
