Subject: **Permission to organizing "Top Thai Brands-2024" Expo**
Reference: Application by Royal Thai Embassy, Dhaka. Dated: 21 May 2024

With reference to the above mentioned subject, the undersigned is directed to convey the permission to the Royal Thai Embassy, Dhaka for organizing international exhibition title "Top Thai Brands 2024" from 10-13 July 2024 at Grand Ballroom, Pan Pacific Sonargaon, Dhaka under the following terms and conditions:

- (a) The duration of the fair cannot be extended without permission of the authority granting permission to hold the fair;
- (b) In case of extension of the period of fair, payment of additional fee to be made by the applicant/applicant organization at the rate mentioned in paragraph 4 of the Fair Circular, 2022;
- (c) If for any reason it is not possible to organize the fair on the scheduled date, the applicant will have to re-apply by paying the fee and it will be treated as a fresh application;
- (d) While organizing a fair at any place, the class of the said land cannot be changed;
- (e) Prohibited import or illegally imported or illegal goods cannot be displayed and sold in the fair and the goods displayed in the fair must be in consistent with the purpose of organizing the fair;
- (f) If any foreign goods or machinery or equipment which is not prohibited for import is required to be displayed or sold in the fair, however, the said foreign goods or machinery or equipment shall be imported following the existing "Import Policy Order";
- (g) Indecent, anti-social and illegal activities cannot be conducted in fairs;
- (h) No activity that hurts the religious sentiments of the people or anything contrary to the history, tradition, culture and social customs of Bangladesh shall be shown or promoted;
- (i) No foreign artists/models/celebrities can participate in the fair without the permission of the Ministry of Cultural Affairs;

(j) The fair must be conducted keeping the local administration and law enforcement agencies informed and the fair organizer must maintain the law and order of the fair on his own initiative;

(k) To prevent covid-19 (corona virus) necessary hygiene rules must be followed;

(l) In case of any organization other than the authorized organization being involved in organizing the fair, permission from this ministry must be taken;

(m) The fair approving authority reserves the right to deny permission to the fair and to cancel the permission of any fair approved if it appears that domestic goods or companies or establishments engaged in the production of domestic goods will suffer; and

(n) In case of violation of the mentioned conditions except condition (m), the fair sanctioning authority can cancel the permission to organize the fair without mentioning any reason.

02. All concerned authorities are requested to provide legal assistance for the approved exhibition.
