Notification



- b) Total period of this study and the time spent for travel and transit will be treated as on duty;
- c) She will draw her pay and allowances in local currency as per rules. No part of it shall be drawn in foreign currency;
- d) All expenses in this regard will be borne by "Australia Awards Scholarship (AAS)";
- e) She will not be allowed to stay abroad without the prior permission of the Government of Bangladesh;
- f) She will be treated as on Deputation (LR) during her study period;
- g) She will submit progress reports to the Department of Agricultural Extension and the Ministry of Agriculture every 6 (six) months;
- h) She will join as Deputation (LR) at the Department of Agricultural Extension after completion of the Course;
- i) She will submit certificate and a report to the Ministry within 07 (seven) days after the completion of the course;
- j) After completion of the course she will serve for the Government at least for 1 year, otherwise will have to refund all the monetary benefits drawn from Government during the said course.


