- d) All expenses in this regard will be borne by “Professor-funded PhD Program”;
- e) He will not be allowed to stay abroad without the prior permission of the Government of Bangladesh;
- f) He will be treated as on Deputation (LR) during her study period;
- g) He will submit progress reports to the Department of Agricultural Extension and the Ministry of Agriculture every 6 (six) months;
- h) He will join as Deputation (LR) at the Department of Agricultural Extension after completion of the Course;
- i) He will submit certificate and a report to the Ministry within 07 (seven) days after the completion of the course;
- j) After completion of the course he will serve for the Government at least for 3 year, otherwise will have to refund all the monetary benefits drawn from Government during the said course.
