Notification

The undersigned is directed to convey the Government's approval of Study leave on Half Average Pay to Mr. Mohibul Islam (Passport No. E00144430), Deputy Director, Bangladesh Tourism Board (BTB), to study a two-year Master's course in "Tourism Economics and Management (TEaM)" at the University of Bologna, Italy. The study leave is initially granted for 01 (one) year from 14.09.2026 to 13.09.2027 under the following terms and conditions:

- He will start his journey toward Italy on a convenient date near 14 September 2026;
 - The approved period of this program and the time spent for travel and transit will be treated as on duty;
 - He will draw all parts of his pay and allowances in local currency as per the Government's Education Leave Rule (Half of Average Pay). No part of it should be drawn in foreign currency;
 - He will bear all expenses related to this study by himself. There will be no financial involvement of the Government of Bangladesh or the Bangladesh Tourism Board (BTB);
 - The study leave period may be renewed for the remaining 01 (one) year subject to the submission of a satisfactory progress report of the course and the application of the concerned officer;
 - As per the submitted bond, he must serve the government for at least 01 (one) year upon returning to the country after completing the course;
 - He will not be allowed to stay abroad beyond the approved period;
 - He will be ineligible to apply for permanent residency and citizenship while studying abroad;
 - The provision of Rule 34 of BSR (Part-I) will be applicable in connection with this approval;
 - He will submit his acquired certificate and a comprehensive report to the Ministry within 07 (seven) working days of his return from completing the course;
 - All terms and conditions of the Public Administration and Higher Education Policy-2023 and other related Rules and Regulations for studying abroad will be applicable.
