- a. The period of this tour including travel and transit will be treated as on duty;
 - b. He will draw his pay and allowances in local currency. No part of it should be drawn in foreign currency;
 - c. All expenses related to visit purpose dated 20-22 January 2026 including travel, lodging and meals will be borne by the Government of the Pakistan;
 - d. All expenses related to the personal tour dated 23-29 January 2026 of BA-6669 Lieutenant Colonel Sami-Ud-Dowla Chowdhury will borne by himself;
 - e. The provision of Rule 34 of Appendix VIII of BSR (Part-1) is applicable for this approval; and
 - f. Overstay will not be permitted at all.
