2. Terms and conditions


- i. The officials will commence their journey to Thailand on or around 2 July 2025 and return upon completion of the program on or around 6 July 2025;
- ii. The entire duration of the visit, including travel and transit, shall be considered as on duty;
- iii. They will draw their pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
- iv. All expenses related to Mr. Md. Ziaul Haque's participation will be borne by UNEP. All expenses related to Mr. Md. Mohiuddin Manik's participation will be borne by UNDP under the "Renewal of the Institutional Strengthening for the Phase-out of ODS (Phase-X)" project. **There will be no financial involvement from the Government of Bangladesh;**
- v. They will not stay abroad beyond the approved period (except for travel time);
- vi. They must report back to their offices immediately upon completion of the program; and
- vii. Each official is required to submit a report on the acquired experience from the program to the Admin-2 Section of the Ministry of Environment, Forest, and Climate Change within seven days of return.
