
Subject: **Government Order (GO) for Participation in the Ninth Meeting of the APFNet Council from 23 to 24 April 2025 in Nha Trang, Vietnam**

The undersigned is directed to convey the approval of the Government of the People's Republic of Bangladesh for **Mr. Md. Amir Hosain Chowdhury, Chief Conservator of Forests (Current Charge)**, Bangladesh Forest Department, Dhaka to participate in the Ninth Meeting of the APFNet Council, scheduled to be held on **23–24 April 2025 in Nha Trang, Vietnam**, jointly organized by the Department of Forestry, Vietnam and APFNet: This approval is granted in accordance with the following terms and conditions:

2. Terms and conditions

- i. The official may commence his journey to Vietnam on or around 22 April 2025 and return on or around 25 April 2025, or on suitable dates based on travel and program schedule;
- ii. The duration of the visit, including travel and transit, will be treated as on duty;
- iii. He will draw his pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
- iv. APFNet will bear all expenses related to the participation of the official in this meeting. **There will be no financial involvement from the Government of Bangladesh;**
- v. He will not stay abroad beyond the approved period (except for travel time);
- vi. He must return to his workplace after completing the program; and
- vii. He is required to submit a report on the meeting to the Admin-2 Section of the Ministry of Environment, Forest, and Climate Change within seven days of his return.

3. This order is issued with the approval of the competent authority.
