Government Order


The undersigned is directed to convey the approval of the Ministry of Environment, Forest and Climate Change, Government of the People's Republic of Bangladesh, for the following official to participate in the "*2nd Quadripartite One Health Workshop for Asia*", scheduled to be held from **25–27 November 2025** in **Bangkok, Thailand**, organized by the Asia-Pacific Regional Quadripartite (FAO, UNEP, WHO, and WOAH).

2. This approval is accorded under the following terms and conditions:

- i. The official will commence his journey to Thailand on or around **24 November 2025** and return on or around **28 November 2025**, subject to travel convenience and the approved program schedule;
- ii. The entire duration of the visit, including travel and transit, shall be treated as on duty;
- iii. He will draw his pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
- iv. All expenses related to his participation in the event(s) will be borne by the Food and Agriculture Organization of the UN (FAO). **There will be no financial involvement from the Government of Bangladesh ;**
- v. The official shall not stay abroad beyond the approved duration except for unavoidable travel requirements;
- vi. He must return to his office immediately upon completion of the program(s); and
- vii. He is required to submit a **brief participation report** to the Admin-2 Section, Ministry of Environment, Forest and Climate Change, within **seven (07) days** of his return.
