

This approval is accorded under the following terms and conditions:

2. Terms and conditions
 - i. The official will leave for Nepal on or around 13 July 2025 and return to Bangladesh upon completion of the program, on or around 16 July 2025, depending on travel convenience;
 - ii. The entire duration of the visit, including travel and transit, shall be considered as on duty;
 - iii. He will draw his pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
 - iv. All expenses related to his participation will be borne by the organizers (UN Women, UNEP, ICIMOD, and the BIMSTEC Secretariat). **There will be no financial involvement from the Government of Bangladesh;**
 - v. He will not stay abroad beyond the approved period (except for travel time);
 - vi. He must report back to his office immediately upon completion of the workshop; and
 - vii. He is required to submit a report on the event to the Admin-2 Section of the Ministry of Environment, Forest, and Climate Change within seven days of his return.
