2. Terms and conditions

- The officials will travel to Namibia on or around 17 August 2025 and return to Bangladesh on or around 23 August 2025, subject to flight availability and travel convenience;
- The entire duration of the visit, including travel and **transit through Ethiopia**, shall be treated as on duty;
- The officials shall draw their pay and allowances in local currency; no part of it shall be drawn in foreign currency;
- All expenses related to their participation will be borne by the NAP Global Network Secretariat. **There will be no financial involvement from the Government of Bangladesh;**
- The officials shall not stay abroad beyond the approved period (except for travel time);
- They must report back to their respective offices immediately upon completion of the event; and
- They are required to submit a report on the forum to the Admin-2 Section of the Ministry of Environment, Forest and Climate Change within seven (7) working days of their return.
