2. Terms and conditions

- They will draw their pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
- All expenses related to his participation will be borne by the **FAO. There will be no financial involvement from the Government of Bangladesh;**
- The officials shall not stay abroad beyond the approved period (except for travel time);
- They must report back to their respective offices immediately upon completion of the program; and
- Each official is required to submit a report on the acquired experience from the program to the Admin-2 Section of the Ministry within seven (07) working days of return.


