2. Terms and conditions

- i. The official will commence his journey to Nepal on or around 22 September 2025 and return on or around 25 September 2025, depending on travel convenience and approved program schedule;
- ii. The entire duration of the visit, including travel and transit, shall be treated as on duty;
- iii. The official will draw his pay and allowances in local currency, with no part drawn in foreign currency;
- iv. All expenses related to his participation in the dialogue will be borne by organizers (ICIMOD & World Bank). **There will be no financial involvement from the Government of Bangladesh;**
- v. The official will not stay abroad beyond the approved period (except for travel time);
- vi. The official must report back to his office immediately upon completion of the program; and
- vii. He shall submit a report on the dialogue to the Admin-2 Section of the Ministry of Environment, Forest and Climate Change within seven days of return.
