

The undersigned is directed to convey the approval of the Ministry of Environment, Forest, and Climate Change, Government of the People's Republic of Bangladesh, for **Ms. Mst Mohsina Akter Banu, Deputy Secretary**, Ministry of Environment, Forest, and Climate Change, to attend the program titled "Third Pole: Understanding the Change and China's Response," scheduled to take place on **12 November 2024** in **Chengdu, China**, organized by the International Centre for Integrated Mountain Development (ICIMOD).

2. This approval is accorded in line with the following terms and conditions :
 - i. The Officer may commence her journey to **China** on a convenient date close to November 12, 2024;
 - ii. The period of this programme and the time spent for travel and transit will be treated as on duty;
 - iii. She will draw her pay and allowances in local currency. No part of it shall be drawn in foreign currency;
 - iv. International Centre for Integrated Mountain Development (ICIMOD) will bear all expenses related to her participation in the aforesaid programme; **there will be no financial involvement from the Government of Bangladesh;**
 - v. She will not be allowed to stay abroad more than the approved period (excluding travel time);
 - vi. She shall return to her workplace immediately after returning from the programme and
 - vii. She will have to submit reports on the programme to the Admin-2 section of the Ministry of Environment, Forest and Climate Change within seven days after her return from the event.
3. This Government Order (GO) is issued with the approval of the competent authority.
