

The undersigned is directed to convey the approval of the Government of the People's Republic of Bangladesh for **H.E. Ms. Syeda Rizwana Hasan, Honorable Advisor**, Ministry of Environment, Forest and Climate Change, Dhaka, to attend the Partnership for a Lead-Free Future (PLF) Launch and the Ministerial Consultation Meeting on the Plastic Pollution Treaty. The PLF Launch is scheduled to be held on 23 September 2024, and the Ministerial Consultation Meeting on the Plastic Pollution Treaty will take place on 25 September 2024 in New York City, USA. This approval is accorded in line with the outlined terms and conditions.

2. Terms and conditions:

- i. The Honorable Advisor may commence her journey to the United States on a convenient date close to September 23, 2024;
- ii. The duration of the programs, including the time spent on travel and transit, will be considered as official duty;
- iii. The Honorable Advisor will draw her pay and allowances in local currency. No part of it shall be drawn in foreign currency;
- iv. The costs related to her participation in the Partnership for a Lead-Free Future (PLF) Launch and the Ministerial Consultation Meeting on the Plastic Pollution Treaty will be borne by the respective organizing entities. Should any expenses arise that are not covered by the organizing entities, those will be executed from the travel expenses code of the Cabinet Division (03-1040301-100121-3244101) according to her entitlement and
- v. She will not stay in the United States beyond the approved period (except for travel days).
