This approval is granted in accordance with the terms and conditions outlined in paragraph 2.

2. Terms and conditions

- i. The Officer will start her journey for **Bangkok** on a convenient date near 14 January 2025;
- ii. The period of this workshop, along with the time spent for travel and transit, will be treated as on duty;
- iii. She will draw her pay and allowances in local currency. No part of it shall be drawn in foreign currency;
- iv. The United Nations Development Programme (UNDP) will bear all expenses of the aforesaid workshop. There will be no financial involvement from the Government of Bangladesh;
- v. She will not be allowed to stay abroad more than the approved period (except travel time);
- vi. She must return to her workplace immediately after completing the workshop; and
- vii. She is required to submit a report on the workshop to the Admin-2 Section of the Ministry of Environment, Forest, and Climate Change within seven days of her return.
