

This approval is accorded under the following terms and conditions:

2. Terms and conditions

- i. The official will commence his journey to Fiji on or around 18 May 2025 and return upon completion of the program on or around 24 May 2025;
- ii. The entire duration of the visit, including travel and **transit through Singapore**, shall be considered as on duty;
- iii. He will draw his pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
- iv. All expenses related to his participation will be borne by the International Organization for Migration (IOM) as per their policy. **There will be no financial involvement from the Government of Bangladesh;**
- v. He will not stay abroad beyond the approved period (except for travel time);
- vi. He must report back to his office immediately upon completion of the program; and
- vii. He is required to submit a report on the exchange visit to the Admin-2 Section of the Ministry of Environment, Forest, and Climate Change within seven days of his return.
