If the funding body does not bear any part of their expenses for this programme, those expenses will be borne by the Government of Bangladesh as per existing rules according to her entitlement.
- iv. They will not stay abroad beyond the approved period (excluding travel time).
- v. They will submit a report on the acquired experiences to this Ministry within 15 working days after their return to Bangladesh.
