This approval is accorded under the following terms and conditions:

2. Terms and conditions


- i. The official will commence her journey to the United States on or around 19 September 2025 and return on or around 12 October 2025, depending on travel convenience;
- ii. The entire duration of the visit, including travel and transit, shall be treated as on duty;
- iii. She will draw her pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
- iv. All expenses related to her participation in the program, including international airfare, domestic travel, per diem, travel allowances, cultural and educational allowances, and other logistical costs, will be borne entirely by the U.S. Government (Organizer). **There will be no financial involvement from the Government of Bangladesh;**
- v. She will not stay abroad beyond the approved period (except for travel time);
- vi. She must report back to her office immediately upon completion of the program; and
- vii. She is required to submit a report on the program to the Administration-2 Section of the Ministry of Environment, Forest and Climate Change within seven days of her return.
