The undersigned is directed to convey the approval of the Government of the People's Republic of Bangladesh for Her Excellency **Ms. Syeda Rizwana Hasan, Honorable Adviser**, Ministry of Environment, Forest and Climate Change, to attend the Ministerial Roundtable on Tackling Water Security Across the Climate-Nature-Development Nexus, scheduled to be held on **13 March 2025** at St. James's Palace, **London, United Kingdom**. Following this event, Her Excellency will also attend the Water and Climate Reception at Buckingham Palace, London, United Kingdom. This approval is granted under the following terms and conditions:

2. Terms and conditions
  - i. Her Excellency will commence her journey to the United Kingdom (UK) on 10 or 11 March 2025, or on a convenient date near that, and depart the UK on 14 or 15 March 2025, or on a convenient date near that;
  - ii. The duration of the visit, including travel and transit, shall be considered on duty;
  - iii. Her Excellency shall draw her pay and allowances in local currency. No part of it shall be drawn in foreign currency;
  - iv. The UK Government will provide funding for Her Excellency's round-trip business-class airfare;
  - v. As per her entitlement, accommodation, daily subsistence allowance (DSA), and other associated expenses shall be covered under the Cabinet Division's 'Travel Expenses' Budget Code: 03-1040301-100121-3244101; and
  - vi. She will not stay abroad beyond the approved period, except for necessary travel time.
