2. Terms and conditions

- iii. They will draw their pay and allowances in local currency. No part of it shall be drawn in foreign currency;
- iv. The UNODC (United Nations Office on Drugs and Crime) will bear all expenses of the aforementioned training. There will be no financial involvement from the Government of Bangladesh;
- v. They will not be allowed to stay abroad for more than the approved period (except travel time);
- vi. They must return to their respective workplaces immediately after completing the training; and
- vii. They are required to submit a report on the training to the Admin-2 Section of the Ministry of Environment, Forest, and Climate Change within seven days of their return.
