The undersigned is directed to convey the approval of the Ministry of Environment, Forest & Climate Change, Government of the People's Republic of Bangladesh for **Mr. Gobinda Roy, Deputy Chief Conservator of Forests and Project Director**, Sustainable Forests and Livelihood (SUFAL) Project, Bangladesh Forest Department, Dhaka, to participate in the Capacity Development Program on Knowledge Exchange on Blue Carbon, scheduled to be held from **31 March 2025 to 04 April 2025** in **Seoul and Jeju, Republic of Korea**. 2. Terms and conditions

- i. The official will commence his journey for **Republic of Korea** on a convenient date near **31 March 2025**;
- ii. The duration of the visit, including travel and transit, shall be considered on duty;
- iii. He will draw his pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
- iv. The World Bank will cover all expenses related to his participation. **There will be no financial involvement from the Government of Bangladesh**;
- v. He will not stay abroad beyond the approved period (except for travel time);
- vi. He must return to his workplace after completing the program; and
- vii. He is required to submit a report on the program to the Admin-2 Section of the Ministry of Environment, Forest, and Climate Change within seven days of his return.
