- All expenses related to their participation in the event(s) will be borne by GIZ. **There will be no financial involvement from the Government of Bangladesh ;**
- The officials shall not stay abroad beyond the approved period (except for travel time);
- They must report back to their respective offices immediately upon completion of the workshop; and
- They are required to submit a brief report on the workshop to the **Administration-2 Section**, Ministry of Environment, Forest and Climate Change within seven (07) days of their return.

3. This order is issued with the approval of the competent authority.


