
Subject: **Government Order for Participation in the Technical Exposure Visit to South Korea on Plastic Waste Recycling Technologies, 20–26 July 2025**

2. Terms and conditions
 - i. The officials will travel to South Korea on or around 19 July 2025 and return to Bangladesh on or around 27 July 2025, subject to flight availability and travel convenience;
 - ii. The entire duration of the visit, including travel and transit, shall be treated as on duty;
 - iii. The officials will draw their pay and allowances in local currency; no part of it shall be drawn in foreign currency;
 - iv. All expenses related to their participation will be borne by UNIDO. **There will be no financial involvement from the Government of Bangladesh;**
 - v. The officials shall not stay abroad beyond the approved period (except for travel time);
 - vi. They must report back to their respective offices immediately upon completion of the event; and
 - vii. They are required to submit a report on the visit to the Admin-2 Section of the Ministry of Environment, Forest and Climate Change within seven (7) working days of their return.
