2. Terms and conditions

- i. The officers will start their journey to Geneva, Switzerland, on a convenient date near **3 February 2025**;
- ii. The period of this course, along with the time spent for travel and transit, will be treated as on duty;
- iii. They will draw their pay and allowances in local currency. No part of it shall be drawn in foreign currency;
- iv. CITES Secretariat will bear all expenses of the above participants for the aforesaid course. **There will be no financial involvement from the Government of Bangladesh;**
- v. They will not be allowed to stay abroad more than the approved period (except travel time);
- vi. They must return to their respective workplaces immediately after completing the course; and
- vii. They are required to submit a report on the course to the Admin-2 Section of the Ministry of Environment, Forest, and Climate Change within seven days of their return.


