2. Terms and conditions
 - i. The official will depart for Morocco on or around **15 June 2025** and return on or around **19 June 2025** after completion of the program;
 - ii. The entire duration of the visit, including travel and transit, shall be considered as on duty;
 - iii. She will draw her pay and allowances in local currency, and no part of it shall be drawn in foreign currency;
 - iv. All expenses related to her participation will be borne by the Government of Morocco/organizers of the Country-Led Initiative as per their policy. **There will be no financial involvement from the Government of Bangladesh;**
 - v. She will not stay abroad beyond the approved period (except for travel time);
 - vi. She must report back to her office immediately upon completion of the program; and
 - vii. She is required to submit a report on the program to the Admin-2 Section of the Ministry of Environment, Forest and Climate Change within seven days of her return.
