There is no financial involvement of the Government of the People's Republic of Bangladesh with this tour;
- v. They will not stay abroad beyond the approved period (excluding travel time);
- vi. They will return to their respective workplaces immediately after returning from the meeting and

- vii. They will submit a report on the acquired experiences to this Ministry within 10 working days after their return to Bangladesh.
